The Town Board of the Town of Grand Rapids, Wood County, Wisconsin, RESOLVES as follows:

Ordinance 5 – Regulating Circuses, Carnivals, Shows, Concerts, Race Tracks, Exhibitions and Amusements is hereby amended as presented to include the following changes:

**Section 5.8 shall read:**

**5.8 Prevailing Effect of Ordinance 69; Repealer**

Notwithstanding anything set forth above in this Chapter, whenever the provisions of this Chapter are inconsistent, or events seeking permit fall within with those listed in Ordinance No. 69- Requiring a Permit for Public Events on Town Highways, the provisions of said ordinance shall prevail and apply. All other ordinances of the Town of Grand Rapids which are in conflict herewith are hereby repealed to the extent of such conflict

The Town Board of the Town of Grand Rapids, Wood County, Wisconsin, has the specific authority under § 19.34, Wis. Stats. to amend this ordinance.

This ordinance amended by a majority of the town board with a quorum present and voting and proper notice having been given, amends the attached Ordinance 5 – Regulating Circuses, Carnivals, Shows, Concerts, Race Tracks, Exhibitions and Amusements.
