**RESOLUTION NO: 2017-05  
Re: Ordinance No. 55 – Fireworks**

The Town Board of the Town of Grand Rapids, Wood County, Wisconsin,  
RESOLVES as follows:

Ordinance 55 – Regulating the Sale or Use of Fireworks is hereby amended as presented.

The Town Board of the Town of Grand Rapids, Wood County, Wisconsin, has the specific authority under § 19.34, Wis. Stats. to amend this ordinance.

Revisions to be made to the following sections in the Fireworks Ordinance:

**55.3 Sale/Use/Possession**

- B. No person may use fireworks or a device listed in sec. 167.10(1)(e) and (k)-(n) Wis. Stats. while attending a fireworks display for which a permit has been issued pursuant to this Ordinance.
- D. The Town of Grand Rapids prohibits any person from allowing or permitting fireworks to be used or exploded on his or her premise or premises under his or her control except as authorized by sec. 167.10 Wis. Stats, or a Town of Grand Rapids Fireworks Permit.


**55.5 Penalty**

- A. Any person(s), firm or corporation who has in their possession or is convicted using or permitting use on his or her premises of illegal fireworks in the Town of Grand Rapids shall, upon conviction, be subject to a forfeiture per Ordinance 39 “Schedule of Fees and Forfeitures” together with the costs of prosecution.


This ordinance amended by a majority of the town board with a quorum present and voting and proper notice having been given, amends the attached Ordinance 55 – Fireworks.
