RE: Amendments to the Town Official Street Map

Recommended by: Plan Commission

For consideration on: March 14, 2017

EXPLANATION: 1) The Town Board of the Town of Grand Rapids, Wood County, Wisconsin at a regular meeting on February 14, 2017 has authorized, pursuant to Sec. 62.23(6), Wis. Stats. an update to the Town of Grand Rapids Official Map through a referral to the Town of Grand Rapids Plan Commission.
 2) The Town Plan Commission reviewed the Official Map at its meeting on February 27, 2017, and thereafter recommended adoption of the proposed amendments by the Town Board.
 3) A Class 2 Notice was provided in accordance with Ch. 985, Wis. Stats. and a copy of the proposed amendment to the Official Map have been on file and open for public inspection in the Office of the Town Clerk for not less than two weeks.
 4) The Town Board accepts the recommendation of the Town Plan Commission and has determined that the proposed amendment is consistent with the Town of Grand Rapids Comprehensive Plan and will serve to further orderly land use development and promote the health, safety and welfare of the Town.

RESOLVED: As recommended by the Town of Grand Rapids Plan Commission at its meeting February 27, 2017, the Grand Rapids Town Board hereby resolves to amend the Official Map to remove and vacate an undeveloped portion of Two Mile Avenue located as follows:

Parcel #0704374 (known as Outlot 2) that reserves a portion of Two Mile Avenue and currently an undeveloped East-West road from 37th St. S. to 40th St S. about 1209 feet South of Airport Avenue, and said road being 66-feet wide and located in the Sunny Acre Subdivision, Section 27 in the Town of Grand Rapids.



The Town of Grand Rapids Town Board hereby resolves to amend the Official Map to remove and vacate the unnamed and undeveloped road in Valentine Subdivision located as follows:

An unnamed, undeveloped East-West road from 80th Street to a point 150 feet West, about 965 feet South of South Park Road, said road being 60-feet wide and located between Lot 1 of Block 1 of the Valentine Subdivision, and Lot 2 of Wood County Certified Survey Map 10078, Section 25 in the Town of Grand Rapids.
