

Resolution Number 2017-14

**PRELIMINARY RESOLUTION FOR DISCONTINUING AN UNNAMED AND UNDEVELOPED ROAD IN VALENTINE SUBDIVISION, TOWN OF GRAND RAPIDS, WOOD COUNTY WISCONSIN**

WHEREAS, the Town Board for the Town of Grand Rapids, on the 11<sup>th</sup> day of April, 2017, by this Resolution adopted by a majority of the Town Board on a roll call vote with a quorum present and voting and proper notice having been given, resolves and orders as follows:

The process under Chapter 66.1003, Wis. Stats. to discontinue a public way in the Town described as follows is hereby initiated:

An unnamed, undeveloped East-West road from 80th Street to a point 150 feet West, about 965 feet South of South Park Road, said road being 60-feet wide and located between Lot 1 of Block 1 of the Valentine Subdivision, and Lot 2 of Wood County Certified Survey Map 10078, all in Section 25, Township 22 North of Range 6 East, in the Town of Grand Rapids, Wood County, Wisconsin.

NOW THEREFORE, BE IT RESOLVED, a Public Hearing to discuss proposed Resolution No. 2017-14 (a copy of which is included in this document, below the Notice) to discontinue a public way in the Town of Grand Rapids shall be held on the 13th day of June, 2017 at the Town of Grand Rapids, Town Hall, 2410 48<sup>th</sup> Street South, Wisconsin Rapids, Wisconsin, beginning at 6:00PM., provided in accordance with a Notice of Hearing as required under Ch. 985, Wis. Stat. The Town Board will at that time consider said Resolution to discontinue the above-noted portion of public way.

BE IT FURTHER RESOLVED, the Town Clerk shall publish a Notice of Hearing as a Class III Notice under Chapter 985, Wis. Stats., and the Town Clerk shall cause the Notice of Hearing to be served on the owners of land abutting the highway to be discontinued, and any other parties required to be served under Wis. Stat. 66.1003(4)(b), in the manner provided for the service of summons in Circuit Court at least 30 days before the hearing, except that when service cannot be made within the Town, a copy of the notice shall be mailed to the owner's last-known address at least 30 days before the hearing.

BE IT FURTHER RESOLVED, that the Clerk shall deliver, on behalf of the Town Board, a copy of this Resolution to the Secretary of Transportation, pursuant to Wis. Stat. 66.1003(8).

A map of the land that will be affected by this application is attached to this resolution, and incorporated by reference.


