**RESOLUTION FOR DISCONTINUING AN UNNAMED AND UNDEVELOPED ROAD IN VALENTINE SUBDIVISION,
PURSUANT TO WIS. STAT. SEC. 66.1003**

WHEREAS, the Town Board for the Town of Grand Rapids, on the 11th day of April, 2017, initiated the process to discontinue an unnamed, undeveloped east-west road from 80th Street to a point 150 feet West, as described below, in accordance with the requirements of Sec. 66.1003(4) Wis. Stats. in the Town of Grand Rapids, through adoption of Resolution 2017-14; and

WHEREAS, the portion of public way to be discontinued is described as:

An unnamed, undeveloped East-West road from 80th Street to a point 150 feet West, about 965 feet South of South Park Road, said road being 60-feet wide and located between Lot 1 of Block 1 of the Valentine Subdivision, and Lot 2 of Wood County Certified Survey Map 10078, all in Section 25, Township 22 North of Range 6 East, in the Town of Grand Rapids, Wood County, Wisconsin.

WHEREAS, a public hearing on the proposed discontinuance of the above-described public way was held in accordance with Sec. 66.1003(4)(b), on June 13, 2017 at 6:00p.m., where the Town of Grand Rapids Town Board heard all reasons that were offered for and against the discontinuance of this public way; and

WHEREAS, the Town Board has determined that the public good of the Town will be promoted, and requires that the discontinuance be made formally and in a matter of public record so that property rights of any adjoining landowner and original landowner can be determined.

A map of the land that will be affected by this Resolution is attached, and incorporated by reference.


NOW THEREFORE, BE IT RESOLVED, that the Town Board hereby vacates the East-West road from 80th Street to a point 150 feet West, about 965 feet South of South Park Road, said road being 60-feet wide and located between Lot 1 of Block 1 of the Valentine Subdivision, and Lot 2 of Wood County Certified Survey Map 10078, all in Section 25, Township 22 North of Range 6 East, in the Town of Grand Rapids and the vacated right-of-way is to be attached to and made part of the lot abutting it on the North (Lot 1 of Block 1 of the Valentine Subdivision), because the road was formed out of the parcel which was subdivided as Valentine Subdivision.

BE IT FURTHER RESOLVED, a Quit-Claim Deed transferring interest pursuant to this duly adopted order of Vacation, shall be recorded with the Register of Deeds of Wood County and shall be filed with the Town Clerk.
