**RESOLUTION FOR AMENDING THE TOWN OF GRAND RAPIDS OFFICIAL MAP,  
PURSUANT TO WIS. STAT. SEC. 62.23(6)**

**WHEREAS**, the Town Board for the Town of Grand Rapids, on the 14th day of February, 2017, initiated the process for review and possible amendments to the Town of Grand Rapids Official Map, in accordance with requirements of Sec. 62.23(6) Wis. Stats.; and

**WHEREAS**, in accordance with the requirements of Sec. 62.23(6)(c), the Town Board, at its meeting on the 14th day of February, 2017 referred the Official Map review to the Town of Grand Rapids Planning Commission, for review and recommendations; and

**WHEREAS**, at its meeting on May 8, 2017, the Town of Grand Rapids Planning Commission made a recommendation to the Town Board to adopt amendments to the Town of Grand Rapids Official Map, removing six future road reservations, adding the Highway 54 (East Arterial) Extension, and altering the location of a future road reservation. A list of the Planning Commission review and recommendations is attached and incorporated by reference; and

**WHEREAS**, a public hearing on the proposed amendments to the Town of Grand Rapids Official Map was held in accordance with the requirements of Sec. 62.23(6)(c), on June 13, 2017 at 6:00p.m., where the Town of Grand Rapids Town Board heard all reasons that were offered for and against the proposed amendments to the Official Map; and

**WHEREAS**, the Town Board has determined that the public good of the Town will be promoted, and requires that amendments to the Town of Grand Rapids Official Map be made formally and in a matter of public record so that property rights of any landowners can be determined.

A map of the land that will be affected by this Resolution is attached, and incorporated by reference.

**NOW THEREFORE, BE IT RESOLVED**, that the Town of Grand Rapids Town Board hereby accepts the recommendations of the Town Planning Commission, and has determined that the proposed amendments to the Town Official Map are consistent with and support the Town of Grand Rapids Comprehensive Plan and will serve to further orderly land use development and promote the health, safety and welfare of the Town.

**BE IT FURTHER RESOLVED**, the updated Town Official Map shall be in full force and effect through the adoption of this Resolution, and said amendments shall become part of the Official Map of the Town on this day.
