Ordinance 7 – Restricted Use of Firearms, Bows & Arrows, Weapons is hereby amended as presented.

The Town Board of the Town of Grand Rapids, Wood County, Wisconsin, has the specific authority under Chapters 60 and 66 of Wisconsin Statutes, and specifically § 60.22, Wis. Stats. to amend this ordinance.

The Ordinance has been revised to include the following:


**7.3(B)(16) Firearm Restrictions**

That portion of the Northwest Quarter of the Southwest Quarter (NW ¼ of SW ¼) which lies northerly and easterly of parcel numbers 0700235A and 0700235 (approximately 37.58 acres), all in Section Fourteen (14), Township Twenty-two (22) North, Range Six (6) East, County of Wood.


