RESOLUTION NO: 2018-12

Re: Ordinance No. 52 – Zoning; Setback Standards Regarding Placement of Structures

The Town Board of the Town of Grand Rapids, Wood County, Wisconsin,
 RESOLVES as follows:

Ordinance 52 – Zoning is hereby amended as presented.

The Town Board of the Town of Grand Rapids, Wood County, Wisconsin, has the specific authority under Chapters 60 and 66 of Wisconsin Statutes, and specifically § 60.22, Wis. Stats. to amend this ordinance.

The Ordinance has been revised to include the following, resulting in all remaining items to be re-numbered accordingly:

52.3(G)(3) Structures Permitted within Setback Lines

- g) The Plan Commission is authorized to vary setback standards on corner lots, to allow for placement of a structure otherwise prohibited within a setback area, when it determines such placement is appropriate to the characteristics of a property and its neighborhood. The Plan Commission may, under this section, approve a deviation from the setback requirements on corner lots, only if no opposition from abutting property owners is received after notification by the Zoning Administrator, and a determination is made that such placement would not be seriously disruptive of neighborhood safety and aesthetic character. No variation of setback standards may be found which interferes with a vision triangle as specified in this Zoning Ordinance. The Plan Commission cannot, under this procedure, approve setback variations greater than 30% of a setback measurement.

This ordinance amended by a majority of the town board with a quorum present and voting and proper notice having been given, amends the attached **Ordinance 52 – Zoning**.
