

Resolution Number 2020-24

RESOLUTION FOR DISCONTINUING AN UNDEVELOPED PORTION OF RIDGEWOOD TRAIL, TOWN OF GRAND RAPIDS, WOOD COUNTY, WISCONSIN, PURSUANT TO WIS. STAT. SEC. 66.1003

WHEREAS, the Town Board for the Town of Grand Rapids, on the 18th day of August, 2020, initiated the process to discontinue an undeveloped portion of Ridgewood Trail, as described below, in accordance with the requirements of Sec. 66.1003(4) Wis. Stats. in the Town of Grand Rapids, through adoption of Resolution 2020-21; and

WHEREAS, the portion of public way to be discontinued is described as:

An undeveloped portion of Ridgewood Trail, formally described, to wit: Outlot two (2) of Wood County Certified Survey Map 10737 as recorded June 25, 2020 at 11:40AM in Volume 40 of Certified Surveys, Page 37 as Document No. 2020R05955. Part of Government Lot 3, Section 19, Township 22 North, Range 6 East, and Government Lot 6, Section 24, Township 22 North, Range 5 East, all in the Town of Grand Rapids, Wood County, Wisconsin.

WHEREAS, a public hearing on the proposed discontinuance of the above-described public way was held in accordance with Sec. 66.1003(4)(b), on October 13, 2020 at 6:00p.m., where the Town of Grand Rapids Town Board heard all reasons that were offered for and against the discontinuance of this public way; and

WHEREAS, the Town Board has determined that the public good of the Town will be promoted, and requires that the discontinuance be made formally and in a matter of public record so that property rights of any adjoining landowner and original landowner can be determined.


A map of the land that will be affected by this Resolution is attached, and incorporated by reference.

NOW THEREFORE, BE IT RESOLVED, that the Town Board hereby discontinues the undeveloped portion of Ridgewood Trail, in the Town of Grand Rapids and the vacated right-of-way is to revert to those parcels abutting said land pursuant to Wis. Stat. 66.1005.
