

Resolution Number 2021-08

RESOLUTION FOR DISCONTINUING AN UNDEVELOPED PORTION OF ACACIA AVENUE, TOWN OF GRAND RAPIDS, WOOD COUNTY, WISCONSIN, PURSUANT TO WIS. STAT. SEC. 66.1003

WHEREAS, the Town Board for the Town of Grand Rapids, on the 13th day of April, 2021, initiated the process to discontinue an undeveloped portion of Acacia Avenue, as described below, in accordance with the requirements of Sec. 66.1003(4) Wis. Stats. in the Town of Grand Rapids, through adoption of Resolution 2021-04; and

WHEREAS, the portion of public way to be discontinued is described as:

An undeveloped East-West portion of Acacia Avenue, from its point of intersection with Golf Course Road to a point 266.62 feet East where said road intersects Country Lane; said portion of road being 30-feet wide and more particularly described as follows:

Commencing at the NW Cor. of Lot 1 of CSM 9399, said point being the POINT OF BEGINNING. Thence along the Easterly R/W Line of Golf Course Road on a bearing of N 00°58'00" W a distance 30.00'. Thence along the North R/W Line of Acacia Ave. on a bearing of S 89°27'01" E a distance 266.62'. Thence along the West R/W Line of Country Lane on a bearing of S 01°01'38" E a distance 30.00'. Thence S 89°27'01" W a distance 266.62' to the POINT OF BEGINNING. Being situated in Govt. Lot 3, in the Southwest Quarter of the Section 19, Township 22 North of Range 6 East, in the Town of Grand Rapids, Wood County, Wisconsin.

WHEREAS, a public hearing on the proposed discontinuance of the above-described public way was held in accordance with Sec. 66.1003(4)(b), on June 8, 2021 at 6:00p.m., where the Town of Grand Rapids Town Board heard all reasons that were offered for and against the discontinuance of this public way; and

WHEREAS, the Town Board has determined that the public good of the Town will be promoted, and requires that the discontinuance be made formally and in a matter of public record so that property rights of any adjoining landowner and original landowner can be determined.

A map of the land that will be affected by this Resolution is attached, and incorporated by reference.

NOW THEREFORE, BE IT RESOLVED, that the Town Board hereby discontinues the undeveloped portion of Acacia Ave., in the Town of Grand Rapids and the vacated right-of-way is to revert to those parcels abutting said land pursuant to Wis. Stat. 66.1005.
